Section A: Definitions

In these terms and conditions, the following words have meanings as stated

'We', 'Us', 'Our' refer to 'fluidmaths.co.uk'

'You', 'Your' refer to institutions subscribing to and using OUR resources

'Fee', refers to the fee payable by you to use or gain access to the resources.

'Website' refers to 'fluidmaths.co.uk'

'Resources' are the Resources to which you buy access through the website although the sample Resources are free to use.
